## 1. Data Controller

#### 2. Nature of the data and purpose of the processing

### 4. Special categories of personal data

#### 5. Processing methods

#### 6. Nature of the provision

At any time you can exercise the rights provided by the EU Regulation 2016/679 from articles 15 to 22 and in particular the right to:

a) request confirmation of the existence or otherwise of personal data;

b) obtain information about the purposes of the processing, the categories of personal data, the recipients or the categories of recipients to whom the personal data have been or will be communicated and, when possible, the storage period;

c) obtain the correction and deletion of data;

d) obtain the treatment limitation;

e) obtain the portability of the data, that is, receive data from a data controller, in a structured format, commonly used and readable by an automatic device, and transmit them to another data controller without hindrance;

f) object to the processing at any time and also in the case of processing for direct marketing purposes;

g) oppose an automated decision-making process relating to physical persons, including profiling.

h) ask the data controller to access personal data and to correct or delete them or limit the processing that concerns them or to oppose their treatment, in addition to the right to data portability;
